As proposed by the Incharge CNEC, sanction is hereby accorded to the constitution of committee with the following composition to establish and oversee the procedures for availing the services of private entities for conducting skill based courses under PMKVY.

1. Dr. Vinod Kumar, Teaching Associate / Incharge CNEC.
2. Shri Aijaz Ahmed Mulla, Assistant Faculty.
3. Shri Virpratap Singh, Communication Associate.
4. Dr. Amit Sharma, Teaching Associate.
5. Smt. Saba Nazir, Assistant Faculty.

**Terms of Reference for the aforementioned Committee shall be as under:**

1. To invite & receive the LOI's from eligible stake holders in this regard.
2. To project the target (District wise & course wise) in consultation with the eligible stake holders as well as keeping in view the resources available at our end for both regular as well as RPL courses.
3. To collate the LOI proposals after thorough examination & to recommend the best private player on terms of expertise / past experience in conducting PMKVY courses, 3 years IT return, available infrastructure/ ability to raise the requisite infrastructure / equipments within short notice of 10 days.
4. The committee may recommend the best private player for one district or group of districts or on divisional basis only.
5. The committee shall also formulate & recommend the terms & conditions to be followed by the selected private player while implementing the PMKVY courses besides the draft MOU to be entered with the selected private player.
6. The committee shall ensure that a clear transparent process is adopted in receiving the LOI's from all eligible stake holders & its subsequent examination & collation in terms of both technical capabilities & financial proposals.
7. While recommending in clear cut terms, the aforementioned committee shall ensure that the interest of JKEDI both in terms of reputation &

The committee shall submit its report alongwith recommendations, within next 05 days positively.


