Whereas, during the updation of HRMS of employees of JKEDI the Accounts Officer/DDO of the institute reported certain discrepancies in the service records of Shri Surjeet Singh Sodhi S/O Kawal Nain Singh Sodhi with respect to the name & parentage of the aforementioned employee.

Whereas, HRMS of the aforementioned employee couldn't be verified due to the discrepancies with respect to the name in his service records.

Whereas, As per circular issued by the Finance Department (Codes Division) issued vide no: FD-Code/154/2022-03 dated 10.05.2023 with subject, change of name by Government employees-Procedure thereof point no. (I) "All cases of addition / deletion or change in name / surname;

- i. A government employee wishing to adopt a new name or to effect any modification in his / her existing name may do so, formally by a deed changing his / her name. The sample deed form is enclosed.
- ii. The execution of the deed should be followed by publication of the change in a prominent local newspaper at the Government employee's own expense.


The change in the name shall be made with Aadhaar authentication and complete verification of record of e-HRMS".

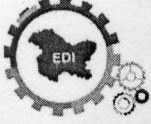
Whereas, the said employee accordingly submitted necessary deed, copy of newspaper with information published regarding correction in name & a copy of Aadhaar card.

Whereas, in response to the publication of public notice in daily newspaper seeking objections if any in this regard, this office has not received any objection within stipulated time frame from the issuance of the publication as reported by the concerned section.

Whereas, in view of the above, the case was further examined by the HR Section & has recommended correcting the name of the official with necessary corrections to be allowed in the service records.

- ii. allowing/establishing the necessary corrections wherever required in the service records of the official.


